

**CHILDREN’S ONLINE PRIVACY
PARENTAL CONSENT**

In accordance with our Children’s Online Privacy Policy, any child under age 13 (“**Child**” or “**Children**”) must have parental consent before the Elizabeth Smart Foundation (“**we**,” “**us**,” “**our**,” and the “**Foundation**”) can collect, use, or disclose a Child’s personal information collected by the Foundation. We will not (i) grant your Child access to any accounts on the Sites, (ii) allow your Child to participate in Smart Defense or any other programs offered by the Foundation, or (iii) allow your Child to participate in certain other Services requiring parental consent, unless we have received your consent. If you do not return your consent within a reasonable time from the date you received this notice, the Foundation will delete your Child’s online contact information.
